2. Copy of Admit Card (given by the GGSIPU CET code 124)
3. Copy of Proof of date of birth (Secondary School Certificate).
4. Copy of Certificate and Mark Sheet of the qualifying examination (10+2) issued by the Board/University. In case, the student has passed the qualifying examination through distance /open education of any recognized board/institution, the necessary documentary evidence related to location of his/her study centre should also be produced.
5. Copy of Conduct and Character Certificate from the Head of the Institution from where the qualifying examination (10+2) has been passed or from Gazetted Officer
6. Copy of category certificate, if applicable
7. Copy of application for age relaxation if submitted to University

1. Admission eligibility requirements remain same as mentioned in GGSIPU Admission Brochure 2017-18
2. Admission will be made strictly on merit basis (Rank-wise) and counseling/ admissions will stop when all the seats get filled-up.
